Subject: Engagement of Guest Faculty at National Sports University, Imphal, Manipur.

Applications are invited from the eligible candidates for engagement of Guest Faculty in National Sports University, Imphal, for the filling up of 4 (four) positions purely on a temporary basis for a period of Six (6) months initially and likely to be extended further the period of engagement on a need basis as detailed below. The engagement shall be strictly on a 'per lecture/period basis. The honorarium shall be Rs 1,500/- per lecture/period, subject to a maximum of Rs 50,000/- per month.

1.	Guest Faculty (Sports Nutrition) - 01	 (i) A Master 's degree with 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited Foreign University.
		 (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET, or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET. Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

Minimum Qualifications and Other Eligibility Criteria

2.	Guest Faculty (Boxing) - 01	M. Sc. Sports Coaching in the concerned sports disciplines from an Indian University or an equivalent degree from an accredited Foreign University. OR

Guest Faculty (Athletics) - 01	A Master 's degree with 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) in Physical Education with Diploma in the concerned sports disciplines from an Indian University or an equivalent diploma and degree from an accredited Foreign University.
4.	Guest Faculty (Sports Physiotherapy) - 01	Bachelor's Degree in Physiotherapy (B.P./T./B. Th./P./B.P.Th.), Master's Degree in Physiotherapy (M.&P.Th /M.Th.P./ M.Sc.P.T/ M.P.T.) with at least 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) from a recognized University.

If scheduled, the interview will likely be held at short notice. Applicants should, therefore, refer to the website of National Sports University (www.nsu.ac.in) regularly for any updates in this regard.

GENERAL INSTRUCTIONS/INFORMATION:

- 1. The mere fact that a candidate possesses the qualifications will not entitle him/her for selection. Applicants with higher qualifications, merit, specialization, and qualifications and experience required for a specific post will be given preference.
- 2. Suppression of factual information, supply of fake documents, providing false or misleading information or any other undesirable action by the candidate shall lead to cancellation of his/her candidature.
- 3. Separate applications for each post applied for should be submitted.
- 4. The candidate will have to present himself/herself for the interview, at the place and time mentioned, at his/her expense.
- 5. Canvassing in any form on behalf of any candidate will disqualify such candidate.
- 6. Selection will be made based on the candidate's previous records and performance in the Interview.
- 7. Applications incomplete in any respect will not be considered.
- 8. NO INTERIM QUERIES regarding selection will be entertained.
- 9. The University reserves the right:
 - i) to withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect.
 - ii) to fill or not to fill up some or all the posts advertised for any reasons whatsoever.
 - iii) Number of posts advertised may be treated as tentative. The University shall have the right to increase/decrease the number of posts during selection and make appointments accordingly.
 - iv) to relax any of the qualifications, experience, age, etc., io exceptionally deserving case of all posts on the recommendations of the Selection Committee.
 - v) The selection committee may decide its method of evaluating the performance of the candidates in the interview.
- 10. The University shall verify the documents submitted by a candidate at any time at the time of appointment or during the tenure of the service. In case it is detected that the documents submitted by the candidate are fake or the candidate has clandestine antecedents/background and has suppressed the said information, then his services shall be terminated.
- 11. In case of any inadvertent mistake in the selection process which may be detected at any stage, even after the issue of the appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
- 12. In case of any dispute/ambiguity that may occur in the selection process, the University's decision shall be final.
- 13. The tenure of the services is for a period of 6 (Six) months initially and is likely to be extended further the engagement period on a need basis.
- 14. The Candidates should report at the University at least 30 minutes before the time fixed for the Interview.
